# Ascom wins order of over CHF 3 million from leading network operator in the United States

## Ascom extends success supporting leading operators deploying voice over LTE with major system expansion. Additional orders are expected.

The secured orders totaling over CHF 3 million as part of a major renewal and expansion of the Voice over LTE active testing solution deployed at a tier one United States network operator, with additional orders expected during Q1 2015.
